

## **Financial Aid Application**

At the Hudson Education Center for the Arts, we believe that music should be accessible for everyone. Because of this, tuition assistance from HEC may be available to those with financial need. We strive to support families who cannot afford payments required for music classes and private lessons. Aid is granted based on family income using the Federal Eligibility Guidelines for Reduced Lunch. To determine your eligibility, please view the Income Eligibility Chart and find the annual income for your Household size. To qualify for HEC Financial Aid, your Adjusted Gross Income on your 2019 tax return must be below the yearly income listed on the Income Eligibility Chart. If there are any extenuating circumstances that you would like the HEC Board of Directors to consider when reviewing your application, please explain in the Statement of Need section in the application form.

## **How to Apply for Financial Aid:**

- Complete the Financial Aid Application Form.
- Submit printed copies (for security and confidential purposes) of your Financial Aid Application Form along with a signed copy of pages one and two of your 2019 federal tax return. Please block out all Social Security numbers.
  - If you are not required to file a tax return because of your income level, please create a Statement of Income and attach it to your Financial Aid Application Form instead.

## 2020-2021 Financial Aid Deadlines

Summer: July 1, 2020
Fall: September 1, 2020
Winter: January 1, 2021
Spring: March 1, 2021

Financial Aid is awarded to qualifying students on a first-come, first-served basis and as available funds permit. Withdrawal from any performance program or ensemble during the semester for any reason, except for special circumstances approved by the Hudson Education Center Director, will result in revocation of the financial aid award. Approved withdrawals will result in prorated aid according to the number of/classes/sessions received on the date of withdrawal. In some cases, an additional payment may be required. Early withdrawal without the approval of the HEC Board of Directors will result in revocation of the financial aid and full
